The human serums are tested by a CE/FDA licensed method and found to be non- reactive for HIV-1, HIV-2, Hepatitis B surface antigen and HCV. Because no test method can offer absolute assurance that these agents are absent, reagents should be handled at the Biosafety Level 2, as recommended for any potentially infectious human blood product.
